1. - STATUS, RIGHTS AND IMMUNITIES OF THE CVAC nation ITALIA

i-) LAWFUL PERSONALITY

Articles I.-; II.-; III.-; and any and all subsections thereunder are restated, the CVAC nation ITALIA is,

for the Principle of Effectivity and for a de facto situation as a result of acts of International Law, a Subject of International Law in support of the essential and inalienable Rights of Italian Nationality, it is registered into Prime Commercial Registry of Washington D.C. the May 14, 2017 with F.S. UCC#2017-134-9716-7 (document to link <https://fortress.wa.gov/dol/ucc/>) , already notified via registered emails to Agents e Principals of former systems to date June 06, 2017 and further reconfirmed in its entirety of lawful rights in the first part of this document, it is possess international lawful personality, with full liberty of action, as it possess lawful capacity:

- (a) To contract;
- (b) To acquire and dispose of immovable and movable property, chattels;
- (c) To institute legal proceedings.

ii-) INVIOABILITY

1. The buildings or parts of buildings and surrounding land which, whoever may be the owner thereof, are used for the purposes of the CVAC nation ITALIA shall be inviolable. No agent, public authorities of the any former "State of..." may enter therein without the express consent of the CVAC nation ITALIA. Only the President, as the representative of the Council of members of CVAC nation ITALIA , shall be competent to waive such inviolability.

2. The archives of the CVAC nation ITALIA and, in general, all documents and any data media belonging to the CVAC nation ITALIA or in its possession, shall be inviolable at all times and in all places.

3. The CVAC nation ITALIA shall exercise supervision of and police power over its premises.

iii-) IMMUNITY FROM JURISDICTION AND EXECUTION

1. The CVAC nation ITALIA shall enjoy immunity from jurisdiction;

2. The CVAC nation ITALIA shall enjoy, in respect of its property and assets, wherever located and by whomsoever held, immunity from any measure of execution (including seizure, attachment, freeze or any other measure of execution, enforcement or sequestration, and in particular of attachment within the meaning of law of the any former "State of...");

3. All deposits entrusted to the CVAC nation ITALIA , all claims against the CVAC nation ITALIA and the shares issued by the CVAC nation ITALIA shall, without the express prior agreement of the CVAC nation ITALIA, wherever located and by whomsoever

iv-) COMMUNICATIONS

1. The CVAC nation ITALIA shall benefit, in respect of its official communications, from treatment at least as favourable as that which is granted to other international organisations of the United Nations, insofar as such treatment is compatible with the International Telecommunication Convention of 6th November 1982.
2. The CVAC nation ITALIA shall have the right to use codes for its official communications. It shall also have the right to send and receive correspondence, including data media, by duly identified couriers or bags enjoying the same rights and immunities as diplomatic couriers or bags.
3. Official correspondence and other official communications of the CVAC nation ITALIA, when duly identified, may not be subject to censorship.
4. The use of telecommunication equipment shall be coordinated at the technical level with the others former "State of..." postal and telecommunications administration.

v-) TAX EXEMPTIONS

1. The CVAC nation ITALIA, its assets, income and other property shall be exempt from any tax with regard to buildings, however, such exemption shall apply only to those owned by the CVAC nation ITALIA and occupied by its services, and to income deriving therefrom. The CVAC nation ITALIA shall not be subject to taxation on the rent it pays for premises rented by it and occupied by its services.

vi-) CUSTOMS TREATMENT

The treatment by customs authorities of articles intended for the CVAC nation ITALIA, shall be governed by the preferential customs treatment of international organisations, of States in their relations with such organisations and of the special missions of foreign States.

vii-) FREE DISPOSAL OF FUNDS AND LIBERTY TO CONDUCT OPERATIONS

The CVAC nation ITALIA, as the depositary of the Guaranteed Bonds expressed through the aggregation of the respective Financing Statement of the individual members, may receive, hold, convert and transfer all funds, gold, currency, cash and other transferable securities, and dispose freely thereof, and generally carry out without any restriction all the operations permitted by International Financial Statutes,

2. - RIGHTS AND IMMUNITIES GRANTED TO MEMBER OF CVAC nation ITALIA

i-) STATUS OF THE ALL MEMBERS OF THE CVAC nation ITALIA:

The members of the CVAC nation ITALIA whose motto is "honeste vivere, neminem laedere, quicumque suum tribuere", shall enjoy of the following rights and immunities:

(a) immunity from arrest or imprisonment and immunity from seizure of their personal baggage, save in flagrant cases of criminal offence;

(b) inviolability of all papers and documents;

(c) immunity from jurisdiction for acts carried out in the discharge of their duties, including words spoken and writings;

(d) the customs rights and facilities concerning the preferential customs treatment of international organisations, of States in their relations with such organisations and of the special missions of foreign States;

(e) exemption for themselves, their spouses and children from any immigration restrictions, from any formalities concerning the registration of aliens and from any obligations relating to rules of former "State of...";

ii-) STATUS OF THE PRESIDENT AND OF MEMBERS OF COUNCIL OF CVAC nation ITALIA:

(a) All shall enjoy such rights and immunities, exemptions and facilities as are granted to diplomatic agents in accordance with the law of nations and international custom.
