8. AMENDMENT (COLLATERAL CHANGE):

After a brief presentation of the topics, the Council having acknowledged the expiry of the terms of the office of President of member giorgio bionaz, thanks him for the work carried out even in the difficult moments of the affirmation of CVAC nation ITALIA from the date of his last reconfirmation (April 18, 2018) and unanimously of the votes elects claudia zaccarini as the new President of CVAC nation ITALIA for the period from February 06, 2021 to February 05, 2022;

The President claudia zaccarini asks for the support of the whole Council for all the operations necessary for the fulfillment of the office assumed, support confirmed with full availability and pleasure on the part of all those present.

As a subsequent point, the proposal for a Council Support Group to support the Council is formulated; the Council Support Group will be created to express binding opinions in the context of the Council's decisions, to which the final word on every decision is always reserved, giving reasons.

It is also proposed that the number of members of the Council Support Group is initially nine, but that the aforementioned number of participants is dynamic in relation to the problems to be faced and the experts that can be used within the members of the itself CVAC nation ITALIA.

After a brief discussion, the Council takes into consideration the proposal that will be subject, both in the methods of participation in the aforementioned Support Group to the Council and in the changes to the same, of specific arguments and definitions in a subsequent Council meeting.

As a last point, the following is added on February 08, 2021:

on the merits of the urgent need highlighted by the Councilor giorgio bionaz for too many commitments, the Council of CVAC Members accepts his request to be replaced within the Council itself by another available member: the other CVAC members unanimously they decide, after a brief consultation, for the member simonetta massola who subsequently contacted accepts the position of Councilor with good will.
